Together we are on a mission to change the world, one girl at a time!

If you want to be part of a community that is driving change by breaking down barriers that girls face to accessing their right to an education, and also work collaboratively with the Board to steer One Girl to even greater heights, we want to hear from you!

OUR BOARD

The board bears ultimate responsibility for achieving One Girl's goals and mission.

The One Girl Board provides leadership and strategic governance, reviews and approves the organisation's strategic plans, annual budgets, and major initiatives, while monitoring the organisation's performance and supporting the One Girl team.

The Board is currently made up of five Directors, based in Melbourne and Sydney who volunteer their time and expertise to further One Girl's mission.

To support our new strategic direction we are seeking expressions of interest from potential board members with experience and exposure in one or more of the following areas:

- Digital marketing expertise with a focus on growth across digital platforms
- Diverse revenue and fundraising models and movement building
- International development with a particular emphasis on lived experiences or networks and partnerships experience in grassroots organisations

RESPONSIBILITIES

Directors have individual responsibilities under the *Corporations Act 2001* as well as their collective role as the One Girl Board.

In fulfilling their individual general duties, Directors must always uphold and abide by One Girl's Constitution, Board Charter and policies.

Directors must exercise their powers and discharge their duties with the degree of care and diligence of a reasonable person in good faith and in the best interests of One Girl. In accordance with the *Corporations Act 2001*, Directors must not improperly use their position or any information.

EXPECTATIONS

As a Director, you will be expected to strongly advocate for One Girl and where appropriate, use your personal and professional networks to help further our mission. You will be constantly looking for ways to add value to the organisation.

All Directors are expected to have sound financial literacy and must comply with their duties as Directors under legislation and common law, and with the duties described in the Australian Charities and Not-for-profits Commission Act.

The board meets approximately every two months, usually in the evening either online or in a hybrid format including onsite at One Girl's office in Abbotsford, Melbourne, VIC. It is expected that Board Members attend all meetings, to the extent possible. Outside formal meetings, it is expected that Directors take on special duties as required, amounting to no more than one day per month.
